

## Weis Summer Adventure Sweepstakes

### OFFICIAL RULES

#### NO PURCHASE NECESSARY

#### A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING

- 1. ELIGIBILITY:** The Weis Summer Adventure Sweepstakes (“Sweepstakes”) is open only to legal residents of Delaware, Maryland, New Jersey, New York, Pennsylvania, Virginia, West Virginia who are 18 years of age or older as of June 26, 2019. Any entries which are suspected of being fraudulent (including those using robotic, automatic, programmed or similar methods of participation) will be disqualified, based on determinations made solely by the Administrator. Any person who supplies false information, obtains entries by fraudulent means, or is otherwise determined to be in violation of these rules in an attempt to obtain any prize will forfeit any prize won and will be prosecuted to the fullest extent of the

law. Consumer data will not be shared and will be used for the Sweepstakes and prize fulfillment purposes only.
