Although the NFL player will be selected by the Sponsor, the Winner will choose the NFL team in which the player will be selected from by the Sponsor. Length of the Meet and Greet will be 10-15 minutes. Prize is non-transferable and non-refundable, and no substitutions by Entrants will be permitted. Sponsor reserves the right to substitute prize of equal or greater value in the event of the prize unavailability. The approximate retail value ("ARV") of the prize is \$500. If the event does not take place as scheduled, for reasons such as cancellation, preemption or postponement, or for any reason beyond the control of Sponsor, Winner will receive no compensation. In no event will more than the stated number of prizes be awarded. Notwithstanding anything to the contrary herein, the winner must be available to attend the Meet and Greet. Should a winner be unable to attend the Meet and Greet, the prize will be forfeited in its entirety and may be awarded to an alternate winner in accordance with these Official Rules. - 5. WINNER NOTIFICATION: Prize Winner will be notified by phone or email, in Administrator's discretion. The Winner is responsible for all federal, state, and local taxes, if applicable.
