

## P&G Football Sweepstakes

### OFFICIAL RULES

#### NO PURCHASE NECESSARY

#### A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING

- 1. ELIGIBILITY:** The P&G Football Sweepstakes (“Sweepstakes”) is open only to legal residents of the states of Connecticut, Delaware, Florida, Georgia, Maine, Maryland, Massachusetts, Michigan, New Hampshire, New Jersey, New York, North Carolina, Ohio, Pennsylvania, Rhode Island, South Carolina and Virginia who are 18 years of age or older as of September 17, 2020. Officers, directors, and employees of Sweepstakes Entities (as defined below), immediate family members (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside) and/or those living in the same household of such persons (whether or not related thereto) are not eligible to participate or win. “Sweepstakes Entities” shall include ProCamps (“Sponsor” and “Administrator”), BJ’s Wholesale Club, Inc., and their parent companies, subsidiaries, affiliates, advertising/marketing agencies and their respective directors, officers, employees or agencies, partners, and prize suppliers. By entering the Sweepstakes, participants (“Entrants”) are bound by and agree to these Official Rules. All federal, state, and local laws and regulations apply. Void where prohibited by law.
- 2. TO ENTER:** No purchase is necessary, and a purchase does not increase chances of winning. The Sweepstakes begins at 12:00:00 AM ET on September 17, 2020 and ends at 11:59:59 PM ET on October 14, 2020 (“Sweepstakes Period”). To enter, during the Sweepstakes Period, a) purchase any 2 of the participating products or b) by mailing a postcard with name, address (including zip code), home and work phone numbers to ProCamps, ATTN: P&G Football Sweepstakes, 4600 McAuley Place, 4<sup>th</sup> Cincinnati, Ohio 45242. Limit one (1) entry per person/email address, per day, during the Sweepstakes Period. All entries become the property of Sponsor and will not be acknowledged or returned. Sponsor and Administrator will not be responsible for incomplete, late, lost, misdirected, illegible, postage-due or late entries.
- 3. PRIZE:** There are (2) prizes. Prize consists exclusively of: the opportunity for one Winner and three (3) guests to participate in a virtual “Meet and Greet” event with one (1) NFL player (such player to be selected by Sponsor in its sole discretion) via a video conferencing platform (such video conferencing platform selected by Sponsor in its sole discretion) on a date and time determined by Sponsor. Although the NFL player will be selected by the Sponsor, the Winner will choose the NFL team in which the player will be selected from by the Sponsor. Length of the Meet and Greet will be 10-15 minutes. Prize is non-transferable and non-refundable, and no substitutions by Entrants will be permitted. Sponsor reserves the right to substitute prize of equal or greater value in the event of the prize unavailability. The approximate retail value (“ARV”) of the prize is \$500. If the event does not take place as scheduled, for reasons such as cancellation, preemption or postponement, or for any reason beyond the control of Sponsor, Winner will receive no compensation. In no event will more than the stated number of prizes be awarded. Notwithstanding anything to the contrary herein, the winner must be available to attend the Meet and Greet. Should a winner be unable to attend the Meet and Greet, the prize will be forfeited in its entirety and may be awarded to an alternate winner in accordance with these Official Rules. In order to participate in the Meet and Greet, the Winner is solely responsible for securing access to a computer or mobile device with Internet connectivity and which is

compatible with the Video Platform selected by the Sponsor to be used for the Meet and Great. Sweepstakes Entities are not responsible in the event any Prize Participant is unable to attend the Meet and Greet for any reason, including, but not limited to, as a result of Internet connectivity issues, issues with any computer or mobile device, issues with the Video Platform, and/or the ability to secure any of the foregoing. Any unused portion of the prize will be forfeited.

- 4. SELECTION OF WINNER:** Winner will be selected from among all eligible entries in a random drawing within approximately ten (10) days after Sweepstakes Period end date listed above. The drawing will be conducted by the Administrator, whose decisions are final on all matters relating to the drawing. Odds of winning depend on the number of eligible entries received. Administrator's decisions are final and binding on all matters related to this Sweepstakes.
- 5. WINNER NOTIFICATION:** Prize Winner will be notified by phone or email, in Administrator's discretion. The Winner is responsible for all federal, state, and local taxes, if applicable. Administrator will require Winner(s) to complete, sign, and return a witnessed statement of Eligibility/Liability Release/Publicity Release forms, and other applicable documents, which may require Winner to provide social security number, within five (5) days of the date of the notification. At Administrator's discretion, Winner may be required to produce a picture or some other form of proper identification to claim any prize. If a Winner cannot be contacted, fails to timely claim the prize, is disqualified for any reason, fails to timely execute and return any required forms, or if the prize notification is returned as undeliverable, an alternate Winner will be selected by random draw from all remaining eligible entries at the Administrator's discretion. If by reason of printing, computer, or Internet malfunction or error, or other error, more prizes are claimed than the number of prizes set forth in these Official Rules, a random drawing will be held to award the advertised number of prizes.
- 6. GENERAL RULES:** The Winner agrees to indemnify and hold harmless and waive any and all claims of liability of any kind whatsoever against the Sweepstakes Entities including any accident, loss, injury or death occurring or in any way related to the prizes or use/misuse thereof or while traveling to and/or from a location to obtain or use a prize. Claims may not be resolved through any form of class action. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes materials and the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control. All material submitted becomes the sole property of Sponsor and will not be returned. Sweepstakes Entities are not responsible for any typographical or other error in the printing of the offer, administration of the Sweepstakes or in the announcement of the prize. Sweepstakes Entities assume no responsibility for undeliverable e-mails resulting from any form of active or passive e-mail filtering by a user's Internet service provider and/or e-mail client or for insufficient space in user's e-mail account to receive e-mail.

Proof of submitting entries will not be deemed to be proof of receipt by Sponsor. If an Entrant submits more than the stated number of entries permitted, and/or if the Administrator suspects that an entrant attempted to obtain additional entries by using multiple addresses, card registrations, identities or any other method, all entries submitted by the entrant may be declared null and void. Any entries which are suspected of being fraudulent (including those using robotic, automatic, programmed or similar methods of participation) will be disqualified, based on determinations made solely by the Administrator. Any person who supplies false information, obtains entries by fraudulent means, or is otherwise determined to be in violation of these rules in an attempt to obtain any prize will forfeit any prize won and will be prosecuted to the fullest extent of the

law. Consumer data will not be shared and will be used for the Sweepstakes and prize fulfillment purposes only.

Sweepstakes Entities are not responsible for technical, hardware, software or electronic malfunctions of any kind, lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications, or by any of the equipment or programming associated with or utilized in this Sweepstakes that may limit the ability to play or participate, or by any human error that may occur in the processing of the entries in this Sweepstakes. If for any reason, (including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other cause beyond the control of the Sweepstakes Entities, that corrupts or affects the administration, security, fairness, integrity, or proper conduct of this Sweepstakes), the electronic portion of the Sweepstakes is not capable of being conducted as described in these rules, Administrator shall have the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes. In the event of termination, a notice will be posted online and the drawing will be conducted from among all mail-in entries received and all eligible automatic entries received prior to termination.

The Sweepstakes Entities do not make any warranty, representation or guarantee, express or implied, in fact or in law, relative to the use of the prizes including, without limitation, quality, merchantability and fitness for a particular purpose.

- 7. CONSENT:** Entrant consents to the use of Entrant's name, face, likeness, voice, appearance and/or comments, including but not limited to statements or testimonials, in connection with the Sweepstakes for advertising and publicity purposes for no additional consideration.

GOVERNING LAW & VENUE:** Except where prohibited by law, all disputes concerning this Sweepstakes or the administration of this Sweepstakes shall be settled in Cincinnati, Ohio under the laws of the State of Ohio by arbitration by a single arbitrator chosen under the rules of the American Arbitration Association.
